This limitation of liability shall also apply in the event that photographic materials are otherwise lost or damaged without fault on the part of Stoney Creek Photography.

On signing this this agreement, Stoney Creek Photography will reserve the time agreed upon above. For this reason, all deposits are non-refundable even if the date is changed or if the wedding becomes cancelled for any reason. **A deposit of \$500.00 is due** at the signing of this agreement. Final payment of all necessary expenses including the balance of this contract, parking expenses, mileage, travel, hotel charges or other expenses shall be paid upon delivery of your photography package. No rights are granted until the balance of this contract is paid in full.

I, the undersigned party, hereby warrant, that I am competent to contract in my own name. I confirm that I have read this agreement and am fully familiar with the contents thereof. This agreement shall be binding upon me and my heirs, legal representatives and assigns, and I certify that I have received a complete copy of this agreement with all blank lines completed.
